

# **Photo & Story Release for Guided Path Terminal Cancer Support Website**

## **Introduction**

Guided Path Terminal Cancer Support ("Guided Path") is a non-profit organization dedicated to providing support services to individuals and families facing terminal cancer diagnoses. This Photo & Story Release ("Release") outlines the terms and conditions for the use of your photograph (the "Image") and story (the "Story") by Guided Path on its website and related marketing materials.

## **Grant of Permission**

By signing below, you (the "Releasing Party") grant Guided Path a non-exclusive, royalty-free, worldwide, irrevocable right to:

- Take photographs of you (the "Image").
- Use, reproduce, modify, publish, distribute, and display the Image and Story on its website and related marketing materials, including social media platforms and printed materials.
- Edit the Image and Story, including cropping, minor adjustments for brightness, contrast, and color for the Image, and minor edits for clarity and length for the Story.

## **Use of the Image and Story**

Guided Path will use the Image and Story solely to promote its mission and services in support of individuals and families facing terminal cancer diagnoses. This may include, but is not limited to:

- Highlighting the stories and experiences of individuals served by Guided Path.
- Raising awareness of terminal cancer and the supportive services available.
- Inspiring others facing similar challenges.

## **Your Rights**

- **Image:** You retain all ownership rights to the Image. You have the right to request that Guided Path remove the Image from its website and marketing materials at any time. This request must be made in writing to [info@guidedpathtcs.org](mailto:info@guidedpathtcs.org). Guided Path will use reasonable efforts to remove the Image within 5 business days of receiving your written request.
- **Story:** You retain all ownership rights to the Story. You may request edits to your Story at any time. Guided Path will use reasonable efforts to incorporate these edits within 5 business days. You also have the right to request that Guided Path remove the Story from its website and marketing materials at any time. This request must be made in writing to [info@guidedpathtcs.org](mailto:info@guidedpathtcs.org). Guided Path will use reasonable efforts to remove the Story within 5 business days of receiving your written request.

## **No Compensation**

You understand and agree that you will not receive any compensation for the use of your Image and Story by Guided Path.

**Confidentiality**

- **Image:** Guided Path will not use the Image in a manner that identifies you by name or other personal information without your prior written consent. However, you acknowledge that some personal information may be identifiable from the context of the Image itself (e.g., clothing, location).
- **Story:** You acknowledge that your Story may contain personal information. You hereby grant Guided Path the right to publish your Story, but only after you have reviewed and approved any portion that identifies you by name or other personal information.

**Release**

You hereby release and forever discharge Guided Path, its officers, directors, employees, agents, successors, and assigns from any and all claims, demands, or causes of action arising out of or related to the use of the Image and Story, including, without limitation, any claims for defamation, invasion of privacy, or right of publicity.

**Entire Agreement**

This Release constitutes the entire agreement between you and Guided Path concerning the use of the Image and Story. This Release supersedes all prior or contemporaneous communications, representations, or agreements, whether oral or written.

**Governing Law**

This Release shall be governed by and construed in accordance with the laws of the State of Tennessee.

**Severability**

If any provision of this Release is held to be invalid or unenforceable, such provision shall be struck from this Release and the remaining provisions shall remain in full force and effect.
